6. संस्था की धारा 214-239 के अन्तर्गत सभी एजुकेशन कोड शर्तों को पूरा करना होगा यदि किसी भी समय निरीक्षण के दौरान किसी भी प्रकार की अनियमितता पाई गई तो मान्यता रद्द कर दी जायेगी।
7. सी.डब्ल्यू. एफ., रेडकास तथा स्पोर्ट्स फण्ड की राशि का शेयर विभाग के नियमानुसार हर वर्ष अगस्त से पहले जिला शिक्षा अधिकारी के कार्यालय में जमा करवाना होगा।
8. शिक्षा विभाग का कोई भी अधिकारी विद्यालय के रिकार्ड एवं शैक्षणिक कार्य को किसी भी बैंक कर सकता है।
9. एजुकेशन कोड की धारा 159 के अन्तर्गत भवन इत्यादि नाम अनुसार पूर्ण करना होगा।
